Dr. Jeromy Warner, Psy D: Identifying and Treating Behavior Complicated by Brain Injury in People with Intellectual and Developmental Disabilities

Lincoln, Nebraska Tuesday May 12, 2015

Dr. Warner has been working with Nebraskans with intellectual and developmental disabilities for the past 10 years and has expertise in treating people with brain injuries. Dr. Warner stated that, in his work, he has “**encountered many providers with group homes, vocational centers, schools, and family homes, who were frustrated [in supporting people who exhibited] behaviors that had either worsened for no reason, or did not appear to improve with standard behavioral strategies or even medication. I noticed many such individuals appeared to have a history of brain injury, or had a head injury that was never diagnosed. Regardless of diagnosis, there was improvement in behavioral [outcomes] when the staff became aware of strategies for working with those complex individuals and resources for decreasing symptoms and stabilizing their quality of life.**”

In his presentation, Dr. Warner will discuss his insights related to the prevalence of brain injury, suspected under-reporting and under-diagnosis. His session will cover **strategies to identify and support people with brain injuries**--whether due to trauma, or another cause, such as infection, seizure, stroke, or poor metabolism. This is an area of expertise that has not been widely discussed or addressed with people with intellectual and developmental disabilities so participants should expect to gain new and exciting insight they can use in their everyday work.
